The 62nd Community Art Exhibition is open to all artists 16 years of age or older who reside or work in Lancaster County. If not a county resident, entrants must be a member of the Demuth Foundation.

ENTRIES

All media eligible.

Each artist may enter one piece, which will be accepted for exhibition. Work previously exhibited in a Community Art Exhibition is not eligible. Entries must remain on display until the close of the exhibition. All work must be original and for sale at the opening of the exhibition. Work designed as a set will constitute one entry.

2-Dimensional work must be ready to hang. No clip frames permitted. The entry (including frame) cannot exceed 24 x 24 inches.

Sculptures must not weigh more than 50 lbs., nor exceed 18 x 18 inches at the base, nor exceed 8 feet in overall height.

Dimensions will be strictly enforced to ensure there is space for all entries.

By entering art in this exhibition the artist grants the Museum permission to photograph the work for publicity, catalogue or educational purposes. Submission of entry constitutes the artist's agreement to all conditions in this prospectus.
